We appreciate you choosing Bounce House & Laser Tag Williamsburg for your party celebration. Our hope is that your party will be both memorable and fun. To ensure the best possible experience we ask you adhere to the following:

1. Check-in is located at the front counters. We will hold an ID/Credit card at check in. Card will not be charged till the end of the party depending on method of payment. Each parent must sign a waiver for their child to be able to participate in the Bounce House & Laser Tag activities.
2. The remaining balance of your birthday party must be paid in full after your party room time ends. Bounce House parties must pay for a minimum of 10 children. Laser Tag parties must pay for a minimum of 7 children.
3. **The party room is only accessible for the scheduled one-hour time block for Bounce House and half an hour for Laser Tag, not from the time of arrival/party start time.** In your best interest, and the interest of other birthday parties it is important that you arrive and vacate the party room as scheduled.
4. **The party will begin with the first hour in the inflatable playground/arena and the remaining hour/half hour will be in the party room.** If you have a Mega Bounce party you may stay in the inflatable playground area until the store closes with parental/guardian supervision, **but you must still vacate the party room at the party end time.**
5. Please arrange to bring your own birthday cake or other treat (non-frozen), as we do not provide a birthday cake, and it is therefore the only outside food or beverage permitted. Please do not bring any other outside food, snacks, or drink, as we have a wide variety of food available at our snack bar.
6. We partner with CiCi's pizza, and you may order pizza for your party through us. A large pizza is \$9.00 for cheese/one topping, \$10.00 for 2-3 toppings, and \$12.00 for supreme pizzas (prices subject to change). However, we are not responsible for any errors or late pizza arrivals that are attributable to CiCi's.
7. A host/hostess will be assigned to your party. He/she will deliver your food to you and assist you with any questions/concerns that may arise. The host/hostess will assist in serving the food and drinks and clean up throughout the party room time.
8. All necessary paper goods are supplied by Bounce House & Laser Tag. However, you are welcome to bring colored/themed tabletop goods if you so desire. You may only bring Mylar balloons into the Bounce House & Laser Tag. We do not allow customers to bring in latex balloons, however, we sell them for \$15.00 per dozen.
9. We have complimentary invitations available for your use, and you may pick them up in the store.
10. We do not allow the use of silly string, water guns, confetti poppers, bubble blowers, or any other product that may cause damage to our party room décor. Thank you for your understanding.
11. Bounce House all children to wear socks in order to bounce on our inflatables. If you forget to bring socks, we do sell them at the front desk. Children's socks are \$1.00 and adult socks are \$2.00. Please advise all of your guests of our sock policy, as there are no exceptions.
12. You can choose to add on different options to make your child's party special. A bungee bounce (1 ride) is \$3.00 per guest. You must purchase add-ons for all party guests including the birthday child. Add-ons may be utilized during the first hour allotted for the inflatable playground area, or after your party room time if you opt for the Mega Bounce option.
13. The Bounce House & Laser Tag Williamsburg is not responsible for loss or damage of personal property belonging to those using the facility. However, you are responsible for any damage incurred to the party room during your visit.
14. Bounce House & Laser Tag accepts cash, Visa, MasterCard, Discover, and American Express. No personal checks are accepted.

Please contact us if you need any further clarifications on the above or have any special requirements. We thank you in advance for your cooperation. We value your business and patronage, and look forward to your visit.

All deposits are **NON-REFUNDABLE**. However, we understand that unforeseen circumstances may force you to cancel your party. If this occurs, you may request for your deposit to be turned into a VIP pass in exchange for your non-refundable deposit.
